#### **Director's Message**

April 22 marks the 52<sup>nd</sup> anniversary of Earth Day. What started in 1970 as a movement by 22 million Americans to help raise awareness of environmental issues is now celebrated annually by billions of people around the world.

As the Agency responsible for the implementation of the Illinois Renewable Portfolio Standard which facilitates the development of new renewable generation and other programs, Earth Day presents a perfect opportunity for the Illinois Power Agency to reflect on the work we do to contribute to Illinois' transition to a clean energy future.

For example, since the Adjustable Block Program first opened for project applications in 2019, the Program has supported over 700 MW of new solar distributed generation and community solar projects in Illinois – a vast increase compared to the less than 100 MW of solar that was in Illinois prior to then. In addition, the IPA's competitive procurements have supported over 1,300 MW of new utility-scale solar projects and nearly 700 MW of new utility-scale wind. These successes are leading to environmental benefits for Illinois residents and businesses.

Furthermore, the recent passage of the Climate and Equitable Jobs Act in September of 2021 presents an exciting opportunity for the Agency to accelerate its work toward building an equitable clean energy future. CEJA more than doubles the funding for renewables and increases the goals and targets for the Agency's programs and procurements, while also adding important new considerations to ensure that our state's development of a clean energy economy is done in an equitable manner. As an Agency, we have made great progress in advancing the state's clean energy transition, but there is more work to be done to put Illinois on a path to reach 100% clean energy by 2050.

On this Earth Day, I want to take this moment to thank all IPA employees for their hard work and unwavering commitment to support the state's renewable and zero-carbon energy generation. And I would like to thank all the stakeholders who have contributed their input into our development of programs and procurements. I would also like to remind everyone that we can all do our part, big or small, to celebrate and honor Earth Day. Whether you're setting broad policies to increase renewable energy, building community gardens, or recycling your paper and cans, it all adds up to make a real difference.

### The Illinois Power Agency Announces New Program Administrator for the Adjustable Block Program

The Illinois Power Agency has announced that it has selected **Energy Solutions, Inc.** to serve as the new Program Administrator for the Adjustable Block Program.

The selection was made by the Agency after a careful evaluation of responses to a **Request for Qualifications**, and a subsequent **Request for Proposals**, and was approved by the Illinois Commerce Commission ("ICC") at its Regular Open Meeting on April 21, 2022, pursuant to the ICC's authority under Section 16-111.5(b)(5)(ii)(B)(iii) of the Public Utilities Act.

They reviewed changes in the law governing Illinois solar programs and how the IPA monitors and enforces consumer protection standards. In addition, Brian provided an overview on how community solar fits into Illinois' RPS and discussed how the IPA-administered incentive programs support community solar developments in Illinois.
