## **Illinois Power Agency Announces New Acting Director**

On October 1, 2022, the Illinois Power Agency announced that the Executive Ethics Commission has appointed the Agency's Chief Legal Counsel Brian Granahan as the Agency's Acting Director. To facilitate a smooth transition, the IPA's current Director, Anthony Star, will remain with the Agency in a senior advisory role for a six-to-ninemonth period.

## The Passing of the Torch!

When Anthony Star took over as Director of the Illinois Power Agency in 2013, it was a different job and a different organization. Compared to today, the Agency had a smaller staff and a narrower range of work.

"At that time, the primary focus of the IPA was electricity procurement. The work on renewables was secondary," Star reminisced. "Key concerns in 2013 included how to manage electricity supply risks resulting from changes in levels of municipal aggregation, and the development of sourcing agreements for the proposed FutureGen clean coal plant," he added. While electricity procurement continues to be a vital part of the work today, the Agency's scope increased vastly over the subsequent years due to the significant responsibilities resultant from the Future Energy Jobs Act and later through the Climate and Equitable Jobs Act. Those responsibilities include expanding the reach of the Renewable Portfolio Standard in Illinois with an increasing focus on ensuring equity within the clean energy economy, and supporting at-risk nuclear plants.

Star had previously served as a Policy Advisor to two Chairmen of the Illinois Commerce Commission and, before entering the public sector, he had spent thirteen years at the Center for Neighborhood Technology working on energy policy and environmental sustainability. His prior work in developing the nation's first residential real-time pricing program prepared him for understanding the complex dynamics of energy markets needed to guide the policy choices in the Agency's annual electricity procurement plans.

One of Star's first tasks at the IPA was to improve Agency operations. In its early years, the organization had struggled to develop internal management structures and functions. As the Agency got on a more solid footing, it took on new responsibilities including the implementation of new programs and procurements that support a clean energy future for Illinois. He took on the challenge of developing solar programs that continue to support the installation of solar panels on the roofs of tens of thousands of homes and businesses across the state. Additionally, under his leadership, the Agency has implemented procurements that have led to the development of new large-scale solar and wind farms, and supported the continued operation of at-risk nuclear plants, which are critical to Illinois' goal of reaching net zero emissions by 2050.

When asked what his most significant accomplishment has been as the Director of the IPA, Star pointed to the Agency's maturation. "Seeing the Agency evolve and become a multidisciplinary team, with a staff committed and enthusiastic about the work they do, that has been meaningful."

With his transition to the role of Senior Advisor and Interim Chief for the Planning and Procurement Bureau, Star will focus his remaining time at the Agency on transferring his knowledge and expertise to the new leadership and the rest of the team. "We've gone from being a small Agency where everyone is involved in everything to a team of more specialized individuals carrying out the cause and the work we do. Under Brian Granahan's leadership, I'm confident the Agency will continue to grow. His comprehensive knowledge of the energy sector and unwavering commitment to our work will prove essential in supporting the just and equitable transformation of the state's energy economy," said Star.

The IPA staff is thankful to Anthony for leading the Agency through a period of accelerated growth and significant transformation. When asked what his next chapter looks like, he said, "I hope to take a bit of a break to spend time with my family, finish half-read books, and try some recipes that I never was able to get to. After that, we'll see. I hope to continue to contribute to the crafting of sound energy policy in Illinois and nationally."


### Illinois Power Agency Files the 2023 Electricity Procurement Plan with the ICC for Approval

On September 28, 2022, the Illinois Power Agency filed its 2023 Electricity Procurement Plan with the Illinois Commerce Commission for approval. The Procurement Plan provides a roadmap for the Agency to set forth a procurement approach to secure sufficient electricity, capacity, and associated transmission services, plus any required demand response, to meet the supply needs of residential and small commercial customers of Illinois electric utilities. ## **Did You Know?**

Did you know that Illinois Shines' traditional community solar program will open for new project applications on November 1, 2022? Last year, the enactment of CEJA paved a path forward for community solar in Illinois in a meaningful way.

CEJA allocated program capacity to support 250 MW of community solar projects to be taken off the waitlists of previous community solar applications in the Spring of 2022. Additionally, the



reopening of the traditional community solar program will allocate additional block capacity of 160 MW for new projects, and the next block capacity of 200 MW in June 2023.

## Illinois Power Agency Announces Updated Names for the Illinois Solar for All Sub-Programs

On August 31, 2022, the Illinois Power Agency **announced** updated names for the Illinois Solar for All (ILSFA) sub-programs.

- *Low-Income Single-Family and Small Multifamily Solar* (formerly Low-Income Distributed Generation, 1-4 units) is now called **Illinois Solar for All: Residential Solar (Small)**.
- Low-Income Large Multifamily Solar (formerly Low-Income Distributed Generation, 5+ units) is now called Illinois Solar for All: Residential Solar (Large).
- *Low-Income Community Solar* is now called **Illinois Solar for All: Community Solar**.
- *Non-Profit and Public Facilities* is now called **Illinois Solar for All: Non-Profit and Public Facilities**.

The new participant-friendly names will help reduce barriers to getting involved by making terminology simpler and easier to understand. Furthermore, the changes will support solar contractors who are participating in ILSFA in their efforts to effectively market the sub-programs. The changes will appear in all program documents and participant-facing materials for Program Year 5, which lasts from Fall 2022 through Spring 2023.
