Hello,

This is not an official comment on behalf of anyone (at least at this point), but I wanted to let you know of an error in your report. Specifically, the last column of the table excerpted from the report below is either mislabeled or miscalculated. The label could be "RECs Under Contract as a Percent of Target," not "REC Shortfall From Target," or the numbers could be changed.

Using the first year for example, the total RECs are 13.41% of the Target (not Shortfall from the Target). The "REC Shortfall" would be 21,149,182 minus 2,835,718 = 18,313,464. Therefore, the "REC Shortfall From Target" would be 18,313,464/21,149,182, or 86.59% (which is the 100% minus the 13.41% in the table). To be correct, you would need to either change your column title, or change the numbers.
