# STATE OF ILLINOIS REQUEST FOR PROPOSALS ILLINOIS POWER AGENCY PROFESSIONAL SERVICES – PROGRAM EVALUATION (ILLINOIS SOLAR FOR ALL) Reference Number 25-RFP-01 (rev)

The Illinois Power Agency ("Agency" or "State") issues this Request for Proposals ("RFP") seeking qualified and responsible experts or expert firms ("Offerors") to serve as the independent Evaluator for the Illinois Solar for All Program. A brief background and description are set forth below.

The Agency welcomes responses from Qualified Offerors able and willing to meet the requirements of this RFP. A Qualified Offeror is an Offeror on the list of respondents to the Request for Qualifications 25-RFQ-01 issued by the Agency on January 24, 2025 who has been determined by the Agency to be qualified to respond to this RFP. Only Qualified Offerors to 25-RFQ-01 may submit a response to this RFP. Evaluation of responses to this RFP and responses to the prior related RFQ will form the basis for determining the selected Offeror for a contract award.

#### **BACKGROUND:**

Public Act 99-0906 (colloquially known as the Future Energy Jobs Act), which took effect June 1, 2017, amended and expanded the Illinois Renewable Portfolio Standard ("RPS") by requiring the development of programs for the procurement of renewable energy credits from new photovoltaic systems in addition to the competitive procurement processes traditionally conducted by the Agency. Public Act 102-0662 (colloquially known as the Climate and Equitable Jobs Act), which took effect September 15, 2021, provided further updates to those provisions. The implementation of these programs is included in the Agency's Long-Term Renewable Resources Procurement Plan ("Long-Term Plan").<sup>1</sup>

One of the programs detailed in the Long-Term Plan is the Illinois Solar for All Program, "which provides incentives for low-income distributed generation and community solar projects, and other associated approved expenditures."<sup>2</sup> Furthermore, "[t]he objectives of the Illinois Solar for All Program are to bring photovoltaics to low-income communities in this State in a manner that maximizes the development of new photovoltaic generating facilities, to create a long-term, low-income solar marketplace throughout this State, to integrate, through interaction with stakeholders, with existing energy efficiency initiatives, and to minimize administrative costs."<sup>3</sup>

Illinois Solar for All consists of four sub-programs:

- Low-income Single-Family and Small Multifamily Solar (Residential Small)
- Low-income Community Solar
- Incentives for Non-profits and Public Facilities
- Low-income large multifamily solar (Residential Large)

Solar projects are financially supported by contracts to purchase the 15-year output of Renewable Energy Credits ("RECs") from the participating projects. Illinois Solar for All requires that: 1) residential system hosts or community solar subscribers have an income of no more than 80% of Area Median Income ("AMI"), 2) contracts produce "tangible economic benefits" for participants, 3) 25% of program funds are allocated to projects in Environmental Justice Communities, 4) 25% of program funds are allocated to

projects that promote energy sovereignty, and 5) up to 5% of the annual program budget is set aside for grassroots education funding. The current annual incentive budget for the program is approximately \$66.5 million per year. The program also has requirements related to the employment of graduates of job training programs.

The program is currently administered by a third-party program administrator, Elevate Energy ("Program Administrator"). The program launched in 2019 and is in its seventh program year, spanning June 2024 through May 2025. Details can be found on the program website, <u>www.illinoissfa.com</u>, in Section 1-56(b)(2) of the Illinois Power Agency Act (20 ILCS 3855), and in Chapter 8 of the Long-Term Plan. The Agency is also running a separate program for non-income-qualified distributed generation and community solar, the Adjustable Block Program (also referred to as Illinois Shines).<sup>4</sup> Evaluation of the Illinois Shines program is not part of this Solicitation.

Section 1-56(b)(6) of the Act specifically requires evaluation of the Illinois Solar for All Program:

At least every 2 years, the Agency shall select an independent evaluator to review and report on the Illinois Solar for All Program and the performance of the third-party program administrator of the Illinois Solar for All Program. The evaluation shall be based on objective criteria developed through a public stakeholder process. The process shall include feedback and participation from Illinois Solar for All Program stakeholders, including participants and organizations in environmental justice and historically underserved communities. The report shall include a summary of the evaluation of the Illinois Solar for All Program based on the stakeholder developed objective criteria. The report shall include the number of projects installed; the total installed capacity in kilowatts; the average cost per kilowatt of installed capacity to the extent reasonably obtainable by the Agency; the number of jobs or job opportunities created; economic, social, and environmental benefits created; and the total administrative costs expended by the Agency and program administrator to implement and evaluate the program.

The Agency has previously conducted two solicitations to select an Evaluator. The first solicitation (19-RFQ-02/19-RFP-02) selected an independent evaluator who reported on the first three ILSFA program years (through May 2021). The second solicitation (23-RFQ-02/23-RFP-02) selected a new independent evaluator who has completed an annual report for the fourth program year (June 2021 through May 2022), two topic-specific mid-year evaluation reports, and will complete evaluations of two additional program years (through May 2024) and one more mid-year evaluation report during their contract term. **Each of the evaluation reports produced by the selected Evaluators can be found on the Program's website at:** www.illinoissfa.com/evaluation-reports.

This Solicitation represents the second step in the Agency's process of selecting the next independent evaluator.<sup>5</sup> The previously issued RFP, 25-RFP-01 issued on March 5, 2025 was closed on May 16, 2025 without selection or award to a participating Offeror. This RFP, 25-RFP-01 (rev), is a reissuance of the original RFP with a series of updates to provide additional direction and clarification to Offerors. Qualified Offerors, following the Request for Qualifications (25-RFQ-01) have again been invited to submit proposals in response to this more detailed Request for Proposals (25-RFP-01 (rev)).

This Solicitation is exempt from the procedures in the Illinois Procurement Code (30 ILCS 500) pursuant to

Sections 1-25(2) and 1-56(f) of the Illinois Power Agency Act (20 ILCS 3855) and contains alternative bidding procedures pursuant to Section 20-10(i) of the Procurement Code (30 ILCS 500/20-10).

BRIEF DESCRIPTION: The evaluation of the Illinois Solar for All Program sought by the Agency consists of two comprehensive annual reports, each covering a program year. The annual reports will include metrics, analysis, and program improvement recommendations, along with an accompanying summary report that condenses key metrics and recommendations, and a presentation of annual evaluation report findings and recommendations to program stakeholders. Additionally, the Agency seeks brief, focused mid-year reports on specific program topics to be released between the annual reports to provide targeted pertinent analysis to the Agency, stakeholders, and the public. For example: a focused report may focus on energy sovereignty in ILSFA, describing the legislative mandate for dedicating a portion of ILSFA funding towards projects offering participant ownership, an analysis of how to balance the participant benefits of ownership with the responsibilities and risks, and recommendations how ILSFA might better incentivize energy sovereignty projects across all sub-programs. The Agency envisions these reports to be around 20 pages long, although the appropriate length will depend on the topic and level of detail warranted to adequately address the topic. An executive summary PowerPoint presentation should also accompany the reports, to be distributed and presented to Agency leadership. The Agency also desires that the evaluator analyze the Program in comparison to other state income-eligible solar programs nationwide. Additional information on the anticipated scope is included in Section 2 of this RFP.

The purpose of this RFP is to describe in detail the proposed approaches to the services and deliverables listed in Sections 2.2 and 2.3, specific resources available to execute those services and deliverables, and proposed price. Those Offerors invited to respond to this RFP should describe in detail their qualifications and proposed approaches to the services and deliverables listed in Section 2 (Technical Proposal), specific resources available to execute those services and deliverables, and detail the proposed price in Section 3. The Agency will score responses to the RFP to determine the Offeror best suited to serve as the Agency's Illinois Solar for All Program Evaluator. That selection is subject to approval by the Illinois Commerce Commission.<sup>6</sup>

If selected through this RFP process, the selected Offeror will be expected to enter into a binding contract with the Agency. This resulting contract with the awarded Offeror shall have an initial term of approximately July 28, 2025 through June 30, 2027 and will include evaluation of Illinois Solar for All for the program years 2024-2025, 2025-2026, and a portion of 2026-2027. The scope of evaluation and contract term may be amended by the Agency in the event that legislative or regulatory action(s) alter the program evaluation responsibilities of the Agency. Offerors should prepare their submittals based on the terms and scope outlined in this RFP.

#### Please read the entire Solicitation package and submit a Proposal in accordance with the instructions.

All forms and signature areas contained in the proposal package must be completed in full and submitted with the check list technical proposal, pricing proposal, disclosures, and various attachments, which combined will constitute the Proposal. Do not submit the instruction pages with Proposals. Offerors should retain the Instructions and a copy of the Proposal for future reference.

- 1.7 GOVERNING LAW AND FORUM: Illinois law and rule govern this Solicitation and any resulting contract. Offeror must bring any action relating to this Solicitation or any resulting contract in the appropriate court in Illinois. This document contains statutory references designated with "ILCS" Statutes). (Illinois Compiled Vendor may view the full text at www.ilga.gov/legislation/ilcs/ilcs.asp. Sections 1-56 and 1-75 of the Illinois Power Agency Act (20 ILCS 3855) are applicable to this Solicitation.
- 1.8 PUBLIC RECORDS AND REQUESTS FOR CONFIDENTIAL TREATMENT: Proposals become the property of the Agency. Proposals, including late submissions, will not be returned. All Proposals will be subject to public inspection under the Illinois Freedom of Information Act ("FOIA") (5 ILCS 140) and other applicable laws and rules, unless Offeror requests in its Proposal that the Agency treat certain information as confidential. A request for confidential treatment will not supersede the State's legal obligations under FOIA. The Agency will not honor requests to keep entire Offers confidential. Offerors must show the specific grounds in FOIA or other law or rule that support confidential treatment. Regardless, the Agency will disclose the successful Offeror's name, the substance of the Offer, and the price upon final contract award. If Offeror requests confidential treatment, Offeror must submit one additional copy of the Proposal with proposed confidential information redacted. This redacted copy must describe the general nature of the material removed, and shall retain as much of the Proposal as possible. In a separate attachment, Offeror shall supply a listing of the provisions identified by section number for which it seeks confidential treatment and identify the statutory basis under Illinois law and include a detailed justification for exempting the information from public disclosure. Offeror will hold harmless and indemnify the Agency for all costs or damages associated with the Agency defending Offeror's request for confidential treatment. Offeror agrees the Agency may copy the Proposal to facilitate evaluation, or to respond to requests for public records. Offeror warrants that such copying will not violate the rights of any third party.
- 1.9 **RESERVATIONS:** Offeror must read and understand the Solicitation and tailor the Proposal and all activities to ensure compliance. The Agency reserves the right to amend the Solicitation, reject any or all Proposals, and waive minor defects. The Agency may request a clarification, inspect Offeror's premises, interview staff, request a presentation, or otherwise verify the contents of the submittal, including information about subcontractors and suppliers. The Agency will make all decisions on compliance, evaluation, terms and conditions, and shall make decisions in the best interests of the Agency and in accordance with rules and other applicable state and federal statutes and regulations. This competitive process may require that Offeror provide additional information and otherwise cooperate with the Agency. If an Offeror does not comply with requests for information and cooperate, the Agency may reject the Proposal as non-responsive to the Solicitation. Submitting a Proposal does not entitle Offeror to an award or a contract. The Agency's posting Offeror's name in a Bulletin notice does not entitle Offeror to a contract. The Agency is not responsible for and will not pay any costs associated with the preparation and submission of any Proposal. Qualified Offeror(s) shall not commence, and will not be paid for any billable work prior to the date all parties execute the contract.
- **I.10 AWARD:** The Agency is not obligated to award a contract pursuant to this Solicitation. This Solicitation and any subsequent RFP issuance, selection, and award process will follow 20 ILCS 3855/1-56(b)(6). As a result of this Solicitation and any subsequent RFP, the Agency may select

the winning Offeror to evaluate the Illinois Solar for All Program. The Agency's selection is subject to approval by the Illinois Commerce Commission. If the Agency issues an award, the award will be made to the Responsible Offeror whose offer best meets the specified requirements and evaluation criteria. In addition, the contract may be amended by the Agency in the event that legislative or regulatory action(s) alter the program evaluation responsibilities of the Agency.

- **I.11 INCORPORATION OF 25-RFP-01 BY REFERENCE:** This Solicitation (25-RFP-01 (rev)) and Offeror's Proposal, and 25-RFQ-01 and the associated Offeror's Submittal of Qualifications, will be incorporated into and made part of any subsequent contract by reference.
- **I.12 PREQUALIFICATION TO RESPOND TO SUBSEQUENT RFP:** Based on the evaluation of responses to 25-RFQ-01, only Qualified Offerors may respond to this RFP.
- **I.13 EVALUATION OF RESPONSIVENESS:** The Agency determines whether proposals completely and satisfactorily meet the responsiveness requirements of this Solicitation. Submittals that fail to meet minimum Responsiveness and Responsibility requirements will not be considered for subsequent evaluation. The Agency shall assess the information provided and the quality of that information when evaluating proposals. If the Agency finds a failure or deficiency, the Agency may reject the proposal or reflect the failure or deficiency in the evaluation.

**RESPONSIVENESS**: A responsive Offeror is one whose proposal conforms in all material respects to this Solicitation, and includes all required information, forms, and disclosures. Information, forms and disclosures include and may not be limited to:

- Proposal Checklist (Section 1)
- Technical Proposal (Section 2)
- Pricing Proposal (Section 3)
- Attachments AA to NN

The Agency will determine whether the Proposal meets the stated requirements. Differences or deviations that have negligible impact on the suitability of the service to meet the Agency's needs may be accepted or corrections allowed. Except for late submissions, and other requirements that by law must be part of the submission, the Agency may require that an Offeror correct deficiencies as a condition of further evaluation. If no Offeror meets a particular requirement, the Agency may waive that requirement.

**I.14 INTERVIEW/PRESENTATION.** The Agency may invite Offerors to an in-person or video conference interview or presentation to answer questions the Agency may have after evaluating the Offeror's Proposal.

The Agency reserves the right to create a list of Offerors to be invited to an interview or presentation. Only those vendors invited to an interview will be considered for further evaluation and selection for contract award. Offerors having submitted a proposal and interviewed through the course of the original RFP, 25-RFP-01, will be deemed having meet this requirement and will be considered for further evaluation and selection for the contract award. The Agency reserves the right to request an additional interview with any such Offerors as a requirement of this RFP (25-RFP-01 (rev).

**I.15 EVALUATION OF ELEMENTS OF RESPONSIBILITY.** The table below shows elements of responsibility for which the Agency will evaluate proposals—including both the maximum points awarded (1,000) and the minimum points needed for each requirement. Proposals will be scored based on the strength of addressing these elements, with their relative weights in points. Failure to obtain the minimum number of points needed in any element of responsibility (following any

**I.16 PROTEST PROCESS:** Any person may submit a protest relating to the notice of the RFP, the terms of the RFP, and any decision to reject a late offer. An Offeror (i.e., a person who submitted an offer to the IPA in response to this RFP) may protest the rejection of its offer or an award to another Offeror. Any protest must be received by close of business no later than ten (10) calendar days after the protesting party knows or should have known of the facts giving rise to the protest to ensure consideration. Any notice published to the IPA or ILSFA website establishes the "known or should have known" date for the subject matter of the notice. In addition, protests relating to the notice or terms of the RFP must be received within fourteen (14) calendar days after release of the RFP.

Protest submissions must be concise and logically arranged; provide a statement of reasons for the protest specifically identifying any allegedly material violation of the IPA Act, another relevant Illinois law, or the terms of the RFP; and include any supporting facts, arguments, evidence, and documents. Protests that do not establish legally sufficient grounds for protest– that is, a material violation of the IPA Act, other relevant Illinois law, or the terms of the RFP – or that do not include supporting evidence will be denied. Note that this RFP is <u>not</u> subject to the Illinois Procurement Code, and protests based solely on rules applicable under that Code will not be considered.

Within one (1) business day of receiving the protest submission, the RFP Solicitation Contact will assign a staff member from IPA that was not involved in drafting the RFP or evaluating offers to review the protest submission and the RFP. If the protest relates to a rejection of an offer, the staff member will also review all relevant offers submitted in response to the RFP and any other

relevant information such as evaluation materials. That staff member will make a recommendation to the Agency's Director within seven (7) calendar days of being assigned to review the protest. The Director will make the final decision as to the determination of the protest within three (3) calendar days. The IPA will resolve the protest by means of a written determination. In determining the appropriate determination, the Director shall consider whether the protestor established sufficient grounds for protest; the seriousness of the procurement deficiency, if any; the degree of prejudice to other parties or to the integrity of the competitive procurement system; the good faith of the parties; the urgency of the procurement; and the impact of the recommendation on the IPA's mission.

1.17 MINORITY, FEMALE, AND PERSONS WITH DISABILITY PARTICIPATION AND UTILIZATION PLAN: This Solicitation contains a goal to include businesses owned and controlled by minorities, females, and persons with disabilities in the procurement and contracting processes. The utilization goal is 30% of the contract amount and is based on the availability of certified vendors (under the Illinois Business Enterprise Program or "BEP") to perform the anticipated direct subcontracting opportunities of this contract. 



#### 1. TERM AND TERMINATION:

**1.1. CONTRACT TERM:** The anticipated contract has an initial term of July 28, 2025 through June 30, 2027. If a start date is not identified, the term shall commence upon the last dated signature of the Parties.

1.1.1. Vendor shall not commence billable work in furtherance of the contract prior to final execution of the contract.

**1.2. RENEWAL:** The State has the option to renew for the following term(s): Annual renewals for up to one (1) additional year unless otherwise updated or altered through Illinois Statute, with an end date no later than June 30, 2028. In the event of changes in Illinois Statute impacting the terms or scope of the Agency's program evaluation responsibilities, the State may, at its own discretion update these renewal terms to comply with such change in law.

1.2.1. Pricing for the renewal term(s), or the formula for determining price, will be based on the Vendor's response to the Pricing Proposal Section of 25-RFP-01 (rev).

1.2.2. Any renewal is subject to the same terms and conditions as the original contract unless otherwise provided in the pricing section. The State may renew this contract for any or all of the option periods specified, may exercise any of the renewal options early, and may exercise more than one option at a time based on continuing need and favorable market conditions, when in the best interest of the State. The contract may neither renew automatically nor renew solely at the Vendor's option.

**1.3. TERMINATION FOR CAUSE:** The State may terminate this contract, in whole or in part, immediately upon notice to the Vendor if: (a) the State determines that the actions or inactions of the Vendor, its agents, employees or subcontractors have caused, or reasonably could cause, jeopardy to health, safety, or property, or (b) the Vendor has notified the State that it is unable or unwilling to perform the contract.

1.3.1 If Vendor fails to perform to the State's satisfaction any material requirement of this contract, is in violation of a material provision of this contract, or the State determines that the Vendor lacks the financial resources to perform the contract, the State shall provide written notice to the Vendor to cure the problem identified within a specified period of time. 1.3.2 For termination due to any of the causes contained in this section, the State retains its right to seek any available legal or equitable remedies and damages.

#### **1.4. TERMINATION FOR CONVENIENCE:**

1.4.1 The State may, for its convenience and with thirty (30) days of prior written notice to Vendor, terminate this contract in whole or in part and without payment of any penalty or incurring any further obligation to the Vendor.

1.4.2 The Vendor shall be entitled to compensation upon submission of invoices and proof of claim for supplies and services provided in compliance with this contract up to and including the date of termination.

**1.5. AVAILABILITY OF APPROPRIATION**: This contract is contingent upon and subject to the availability of funds. The State, at its sole option, may terminate or suspend this contract, in whole or in part, without penalty or further payment being required, if (1) the Illinois General Assembly or the federal funding source fails to make an appropriation sufficient to pay such obligation, or if funds needed are insufficient for any reason (30 ILCS 500/20-60), (2) the Governor decreases the Agency's funding by reserving some or all of the Agency's appropriation(s) pursuant to power delegated to the Governor by the Illinois General Assembly, or (3) the Department determines, in its sole discretion or as directed by the Office of the Governor, that a reduction is necessary or advisable based upon actual or projected budgetary considerations. Contractor will be notified in writing of the failure of appropriation or of a reduction or decrease.

### 2. PAYMENT TERMS AND CONDITIONS:

**2.1. LATE PAYMENT:** Payments, including late payment charges, will be paid in accordance with the State Prompt Payment Act and rules when applicable. 30 ILCS 540; 74 III. Adm. Code 900. This shall be Vendor's sole remedy for late payments by the State. Payment terms contained on Vendor's invoices shall have no force and effect.

**2.2. Minority Contractor Initiative:** Any Vendor awarded a contract of \$1,000 or more under Section 20-10, 20-15, 20-25 or 20-30 of the Illinois Procurement Code (30 ILCS 500) is required to pay a fee of \$15. The Comptroller shall deduct the fee from the first check issued to the Vendor under the contract and deposit the fee in the Comptroller's Administrative Fund. 15 ILCS 405/23.9.

**2.3. VENDOR ASSURANCE:** The Vendor makes the following assurance and this assurance must be included in each subcontract that the Vendor signs with a subcontractor or supplier. The Vendor, subrecipient or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in performance of this contract. The Vendor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of contracts funded in whole or in part with federal or state funds. Failure by the Vendor to carry out these requirements is a material breach of this contract, which may result in termination of this contract or such other remedy, as the Agency deems appropriate, which may include, but not limited to:

2.3.1. Withholding payments;

2.3.2. Assessing Sanctions;

- 2.3.3. Liquidated Damages; and/or
- 2.3.4. Disqualifying the Vendor from future contracting as non-responsible.

**2.4. EXPENSES:** The State will not pay for supplies provided or services rendered, including related expenses, incurred prior to the execution of this contract by the Parties even if the effective date of the contract is prior to execution.

**2.5. PREVAILING WAGE:** As a condition of receiving payment Vendor must (i) be in compliance with the contract, (ii) pay its employees prevailing wages when required by law, (iii) pay its suppliers and subcontractors according to the terms of their respective contracts, and (iv) provide lien waivers to the State upon request. Examples of prevailing wage categories include public works, printing, janitorial, window washing, building and grounds services, site technician services, natural resource services, security guard and food services. The prevailing wages are revised by the Department of Labor and are available on the Department's official website, which shall be deemed proper notification of any rate changes under this subsection. **2.6. FEDERAL FUNDING:** This contract may be partially or totally funded with Federal funds. If federal funds are expected to be used, then the percentage of the good/service paid using Federal funds and the total Federal funds expected to be used will be provided to the awarded Vendor in the notice of intent to award.

**2.7. INVOICING:** By submitting an invoice, Vendor certifies that the supplies or services provided meet all requirements of the contract, and the amount billed and expenses incurred are as allowed in the contract. Invoices for supplies purchased, services performed and expenses incurred through June 30 of any year must be submitted to the State no later than July 31 of that year; otherwise Vendor may be required to seek payment through the Illinois Court of Claims. 30 ILCS 105/25. All invoices are subject to statutory offset. 30 ILCS 210.

2.7.1. Vendor shall not bill for any taxes unless accompanied by proof that the State is subject to the tax. If necessary, Vendor may request the Agency's Illinois tax exemption number and federal tax exemption information.

2.7.2. Vendor shall invoice at the completion of the contract unless invoicing is tied in the contract to milestones, deliverables, or other invoicing requirements agreed to in the contract. Invoices are to be sent electronically to the Agency's representatives as defined in the contract between Agency and Vendor.

**3. ASSIGNMENT:** This contract may not be assigned or transferred in whole or in part by Vendor without the prior written consent of the State.

4. SUBCONTRACTING: For purposes of this section, subcontractors are those specifically hired to perform all or part of the work covered by the contract. Vendor must receive prior written approval before use of any subcontractors in the performance of this contract. Vendor shall describe, in an attachment if not already provided, the names and addresses of all authorized subcontractors to be utilized by Vendor in the performance of this contract, together with a description of the work to be performed by the subcontractor and the anticipated dollar value or % of awarded contract revenue that each subcontractor is expected to receive pursuant to this contract. If required, Vendor shall provide a copy of any subcontracts within fifteen (15) days after execution of this contract. Vendor shall notify the State of any additional or substitute subcontractors hired during the term of this contract. If required, Vendor shall provide to the State a copy of all such subcontracts within fifteen (15) days after execution of the subcontract. All subcontracts must include the same certifications that Vendor must make as a condition of this contract. Vendor shall include in each subcontract the subcontractor certifications as shown on the Standard Subcontractor Certification form available from the State. If at any time during the term of the Contract, Vendor adds or changes any subcontractors, Vendor must promptly notify, by written amendment to the Contract, the State of the names and addresses and the expected amount of money that each new or replaced subcontractor will receive pursuant to the Contract. 30 ILCS 500/20-120.

**5.** AUDIT/RETENTION OF RECORDS: Vendor and its subcontractors shall maintain books and records relating to the performance of the contract or subcontract and necessary to support amounts charged to the State pursuant the contract or subcontract. Books and records, including information stored in databases or other computer systems, shall be maintained by the Vendor for a period of three years (3) from the later of the date of final payment under the contract or completion of the contract, and by the subcontractor for a period of three years from the later of final payment under the term or completion of the subcontract. If federal funds are used to pay contract costs, the Vendor and its subcontractors must retain its records for five (5) years. Books and records required to be maintained under this section shall be available for review or audit by representatives of: the Agency, the Auditor General, the Executive Inspector General, State of Illinois internal auditors or other governmental entities with monitoring authority, upon reasonable notice and during normal business hours. Vendor and its subcontractors shall cooperate fully with any such audit and with any

investigation conducted by any of these entities. Failure to maintain books and records required by this section shall establish a presumption in favor of the State for the recovery of any funds paid by the State under the contract for which adequate books and records are not available to support the purported disbursement. The Vendor or subcontractors shall not impose a charge for audit or examination of the Vendor's books and records. 30 ILCS 500/20-65.

**6. TIME IS OF THE ESSENCE:** Time is of the essence with respect to Vendor's performance of this contract. Vendor shall continue to perform its obligations while any dispute concerning the contract is being resolved unless otherwise directed by the State.

**7. NO WAIVER OF RIGHTS:** Except as specifically waived in writing, failure by a Party to exercise or enforce a right does not waive that Party's right to exercise or enforce that or other rights in the future.

**8. FORCE MAJEURE:** Failure by either Party to perform its duties and obligations will be excused by unforeseeable circumstances beyond its reasonable control and not due to its negligence including acts of nature, acts of terrorism, riots, labor disputes, fire, flood, explosion, and governmental prohibition. The non-declaring Party may cancel the contract without penalty if performance does not resume within thirty (30) days after the declaration.

9. CONFIDENTIAL INFORMATION: Each Party, including its agents and subcontractors, to this contract may have or gain access to confidential data or information owned or maintained by the other Party in the course of carrying out its responsibilities under this contract. Vendor shall presume all information received from the State or to which it gains access pursuant to this contract is confidential. Vendor information, unless clearly marked as confidential and exempt from disclosure under the Illinois Freedom of Information Act, shall be considered public. No confidential data collected, maintained, or used in the course of performance of the contract shall be disseminated except as authorized by law and with the written consent of the disclosing Party, either during the period of the contract or thereafter. The receiving Party must return any and all data collected, maintained, created, or used in the course of the performance of the contract, in whatever form it is maintained, promptly at the end of the contract, or earlier at the request of the disclosing Party, or notify the disclosing Party in writing of its destruction. The foregoing obligations shall not apply to confidential data or information lawfully in the receiving Party's possession prior to its acquisition from the disclosing Party that were received in good faith from a third-party not subject to any confidentiality obligation to the disclosing Party; that is now or later becomes publicly known through no breach of confidentiality obligation by the receiving Party; or is independently developed by the receiving Party without the use or benefit of the disclosing Party's confidential information.

**10. USE AND OWNERSHIP:** All work performed or supplies created by Vendor under this contract, whether written documents or data, goods or deliverables of any kind, shall be deemed work-for-hire under copyright law and all intellectual property and other laws, and the State of Illinois is granted sole and exclusive ownership to all such work, unless otherwise agreed in writing. Vendor hereby assigns to the State all right, title, and interest in and to such work including any related intellectual property rights, and waives any and all claims that Vendor may have to such work including any so-called "moral rights" in connection with the work. Vendor acknowledges the State may use the work product for any purpose. Confidential data or information contained in such work shall be subject to confidentiality provisions of this contract.

**11. INDEMNIFICATION AND LIABILITY:** The Vendor shall indemnify and hold harmless the State of Illinois, its agencies, officers, employees, agents and volunteers from any and all costs, demands, expenses, losses, claims, damages, liabilities, settlements and judgments, including in-house and contracted attorneys' fees and expenses, arising out of: (a) any breach or violation by Vendor of any of its certifications, representations, warranties, covenants or agreements; (b) any actual or alleged death or injury to any person, damage to any property or any other damage or loss claimed to result in whole or in part from Vendor's negligent performance; (c) any act, activity or omission of Vendor or any of its employees, representatives, subcontractors or agents, or (d) any actual or alleged claim that the services or goods provided under this contract infringe, misappropriate, or otherwise violate any intellectual property (patent, copyright, trade

secret, or trademark) rights of a third party. In accordance with Article VIII, Section 1(a),(b) of the Constitution of the State of Illinois, the State may not indemnify private parties absent express statutory authority permitting the indemnification. Neither Party shall be liable for incidental, special, consequential, or punitive damages.

**12. INSURANCE:** Vendor shall, at all times during the term and any renewals, maintain and provide a Certificate of Insurance naming the State as additional insured for all required bonds and insurance. Certificates may not be modified or canceled until at least thirty (30) days notice has been provided to the State. Vendor shall provide: (a) General Commercial Liability-occurrence form in amount of \$1,000,000 per occurrence (Combined Single Limit Bodily Injury and Property Damage) and \$2,000,000 Annual Aggregate; (b) Auto Liability, including Hired Auto and Non-owned Auto, (Combined Single Limit Bodily Injury and Property Damage) in amount of \$1,000,000 per occurrence; and (c) Worker's Compensation Insurance in amount required by law. Insurance shall not limit Vendor's obligation to indemnify, defend, or settle any claims.

**13. INDEPENDENT CONTRACTOR:** Vendor shall act as an independent contractor and not an agent or employee of, or joint venture with the State. All payments by the State shall be made on the basis of Vendor being an independent contractor of or joint venture with the State.

**14. SOLICITATION AND EMPLOYMENT:** Vendor shall not employ any person employed by the State during the term of this contract to perform any work under this contract. Vendor shall give notice immediately to the Agency's Director if Vendor solicits or intends to solicit State employees to perform any work under this contract.

**15. COMPLIANCE WITH THE LAW:** The Vendor, its employees, agents, and subcontractors shall comply with all applicable federal, state, and local laws, rules, ordinances, regulations, orders, federal circulars and all license and permit requirements in the performance of this contract. Vendor shall be in compliance with applicable tax requirements and shall be current in payment of such taxes. Vendor shall obtain at its own expense, all licenses and permissions necessary for the performance of this contract.

**16. BACKGROUND CHECK:** Whenever the State deems it reasonably necessary for security reasons, the State may conduct, at its expense, criminal and driver history background checks of Vendor's and subcontractor's officers, employees or agents. Vendor or subcontractor shall reassign immediately any such individual who, in the opinion of the State, does not pass the background checks.

## **17. APPLICABLE LAW:**

**17.1. PREVAILING LAW:** This contract shall be construed in accordance with and is subject to the laws and rules of the State of Illinois.

**17.2. EQUAL OPPORTUNITY:** The Department of Human Rights' Equal Opportunity requirements are incorporated by reference. 44 ILL. ADMIN. CODE 750.

**17.3. COURT OF CLAIMS; ARBITRATION; SOVEREIGN IMMUNITY:** Any claim against the State arising out of this contract must be filed exclusively with the Illinois Court of Claims. 705 ILCS 505/1. The State shall not enter into binding arbitration to resolve any contract dispute. The State of Illinois does not waive sovereign immunity by entering into this contract.

**17.4. OFFICIAL TEXT:** The official text of cited statutes is incorporated by reference. An unofficial version can be viewed at <u>www.ilga.gov/legislation/ilcs/ilcs.asp</u>.

**18. ANTI-TRUST ASSIGNMENT:** If Vendor does not pursue any claim or cause of action it has arising under federal or state antitrust laws relating to the subject matter of the contract, then upon request of the Illinois Attorney General, Vendor shall assign to the State rights, title and interest in and to the claim or cause of action.

**19. CONTRACTUAL AUTHORITY:** The Agency that signs for the State of Illinois shall be the only State entity responsible for performance and payment under the contract.

**20. EXPATRIATED ENTITIES:** Except in limited circumstances, no business or member of a unitary business group, as defined in the Illinois Income Tax Act, shall submit a bid for or enter into a contract with a State agency if that business or any member of the unitary business group is an expatriated entity.

**21. NOTICES:** Notices and other communications provided for herein shall be given in writing by via electronic mail whenever possible. If transmission via electronic mail is not possible, then notices and other communications shall be given in writing via registered or certified mail with return receipt requested, via receipted hand delivery, via courier (UPS, Federal Express or other similar and reliable carrier), or by fax showing the date and time of successful receipt. Notices shall be sent to the individuals who signed the contract using the contact information following the signatures. Each such notice shall be deemed to have been provided at the time it is actually received. By giving notice, either Party may change the contact information.

**22. MODIFICATIONS AND SURVIVAL:** Amendments, modifications and waivers must be in writing and signed by authorized representatives of the Parties. Any provision of this contract officially declared void, unenforceable, or against public policy, shall be ignored and the remaining provisions shall be interpreted, to the extent possible, to give effect to the Parties' intent. All provisions that by their nature would be expected to survive, shall survive termination. In the event of a conflict between the State's and the Vendor's terms, conditions and attachments, the State's terms, conditions and attachments shall prevail.

**23. PERFORMANCE RECORD/SUSPENSION:** Upon request of the State, Vendor shall meet to discuss performance or provide contract performance updates to help ensure proper performance of the contract. The State may consider Vendor's performance under this contract and compliance with law and rule to determine whether to continue the contract, whether to suspend Vendor from doing future business with the State for a specified period of time, or to determine whether Vendor can be considered responsible on specific future contract opportunities.

**24. FREEDOM OF INFORMATION ACT:** This contract and all related public records maintained by, provided to, or required to be provided to the State are subject to the Illinois Freedom of Information Act notwithstanding any provision to the contrary that may be found in this contract. 5 ILCS 140.

**25. SCHEDULE OF WORK:** Any work performed on State premises shall be done during the hours designated by the State and performed in a manner that does not interfere with the State and its personnel.

#### **26. WARRANTIES FOR SUPPLIES AND SERVICES**

26.1. Vendor warrants that the supplies furnished under this contract will: (a) conform to the standards, specifications, drawings, samples or descriptions furnished by the State or furnished by the Vendor and agreed to by the State, including but not limited to all specifications attached as exhibits hereto; (b) be merchantable, of good quality and workmanship, and free from defects for a period of twelve (12) months or longer if so specified in writing, and fit and sufficient for the intended use; (c) comply with all federal and State laws, regulations, and ordinances pertaining to the manufacturing, packing, labeling, sale, and delivery of the supplies; (d) be of good title and be free and clear of all liens and encumbrances and; (e) not infringe any patent, copyright or other intellectual property rights of any third party. Vendor agrees to reimburse the State for any losses, costs, damages, or expenses, including without limitation, reasonable attorney's fees and expenses arising from failure of the supplies to meet such warranties.

26.2. Vendor shall insure that all manufacturers' warranties are transferred to the State and shall provide a copy of the warranty. These warranties shall be in addition to all other warranties, express, implied, or statutory, and shall survive the State's payment, acceptance, inspection, or failure to inspect the supplies.

26.3. Vendor warrants that all services will be performed to meet the requirements of the contract in an efficient and effective manner by trained and competent personnel. Vendor shall monitor performances of each individual and shall reassign immediately any individual who does not perform in accordance with the contract, who is disruptive or not respectful of others in the workplace, or who in any way violates the contract or State Policies.
