



IPA, ICC, and IEPA Announce Resource Adequacy Study Stakeholder Workshop

June 3, 2025

Section 9.15(o) of the Illinois Environmental Protection Agency (IEPA) Act directs the IEPA, the Illinois Power Agency (IPA), and the Illinois Commerce Commission (ICC) to “jointly prepare, and release publicly, a report to the General Assembly” that examines the State’s progress toward its renewable energy resource development goals, the status of CO₂e and co-pollutant emissions reductions, the current status and progress toward developing and implementing green hydrogen technologies, the current and projected status of electric resource adequacy and reliability throughout the State for the period 5 years ahead, and provide proposed solutions predicated upon any findings (the “Resource Adequacy Study”).

To commence stakeholder engagement supporting and informing the development of this report on resource adequacy in Illinois, the IPA (including its Procurement & Planning Consultant, Energy and Environmental Economics, Inc. (E3)), ICC, and IEPA will hold a workshop to provide stakeholders with an improved understanding of the process the Agencies will employ to conduct the study, key policy drivers and conditions that will be considered, and the general methodologies expected to be utilized. Further, the workshop will outline the roles of each Agency, expected stakeholder engagement opportunities, and schedule of activities to be completed to meet the December 15, 2025 statutory deadline for report release.

Interested stakeholders are encouraged to attend the workshop using the information below. In preparation for the workshop, the Agencies expect to issue preliminary questions for which direct stakeholder feedback will be requested on the call.
