¹ This notice is provided pursuant to Section 1-75(d-5)(1)(D) of the IPA Act. Information provided in this notice may display rounded values where applicable for practical considerations.

² Under Section 1-75(d-5)(1)(B)(iii) of the IPA Act, the Market Price Index is comprised of “the sum of projected energy prices and projected capacity prices.” By law, projected energy prices are determined using forward market prices for the PJM Northern Illinois Hub, while projected capacity prices are determined using 50% of the applicable PJM Base Residual Auction price for the ComEd Zone added to 50% of the MISO Local Resource Zone 4 auction price.

³ For 2026-2027 Delivery Year, Average Northern Illinois Hub Day-Ahead Price = \$41.39/MWh, 50% of PJM Base Residual Auction clearing price for the ComEd Zone (as defined in Section 4.3 of the Zero Emission Standard Procurement Plan) = \$6.86/MWh, 50% of MISO Planning Resource Auction Local Resource Zone 4 clearing price = \$2.63/MWh.

⁴ Under Section 1-75(d-5)(1)(B) of the IPA Act, the Price Adjustment is the amount, if any, by which the Market Price Index for the applicable delivery year exceeds the Baseline Market Price Index. That amount is then subtracted from the Social Cost of Carbon to produce the ZEC Price (and may only be a downward adjustment).
