## IPA Announces Plan for New Data Project to Enhance Public Awareness of Renewable Energy Development

The IPA is excited to announce its plans to develop the Illinois Clean Energy Dashboard, a new data project designed to convey the story of renewable energy development through data visualization tools.

Through this initiative, the IPA seeks to quantify and illustrate a compelling story of renewable energy growth in Illinois and bolster public understanding of how the IPA's renewable energy programs and procurements support that growth. Features will include maps, charts, and statistics charting the development of new solar, wind, and other projects in Illinois, presented in an accessible and visually engaging manner.



Providing accessible data on renewable energy development is crucial for driving in renewable energy and allowing legislators, the media, and other key constituencies to quickly answer common questions about the growth of renewable energy in Illinois. The IPA looks forward to the development of the Illinois Clean Energy Dashboard and will continue to provide updates on the progress of the project through *Power Brief*.

#### IPA Announces Plan to Conduct Policy Study



On August 23, the **IPA announced** that it will be conducting a Policy Study on three energy policy proposals outlined in **House Bill 3445** (HB 3445) during the 103rd Illinois General Assembly's (ILGA) Spring 2023 Legislative Session. The following proposals will be the subject of the IPA's Study:

- <u>Senate Bill 1587</u> would require the Agency to develop a storage procurement plan to support the development of new energy storage projects.
- <u>House Bill 2132</u> would require the Agency to develop a procurement process to support the development of a new utility-scale offshore wind project in Lake Michigan.
- A policy requiring the Agency to conduct a procurement process to support the development of a new High Voltage Direct Current ("HVDC") transmission project, which the Agency understands to be the Soo Green HVDC Link.

While HB 3445 received an amendatory veto around bill language unrelated to the policy study on August 16, 2023, the Agency plans on proceeding with the Study regardless of the final disposition of HB 3445. The Agency will publish a draft of the Policy Study by January 21, 2024 for public comment and will publish a final Policy Study no later than March 1, 2024.

The Agency has developed the **IPA Policy Study webpage** to share key information and provide visibility into the timeline for Policy Study development.



### IPA Publishes Two Draft Procurement Plans for Stakeholder Feedback

On August 15, the Illinois Power Agency released two draft procurement plans for public comment. Parties seeking to provide comments on the Agency's draft plans are encouraged to **review these plans and submit written feedback**. Additionally, the IPA will be holding virtual public hearings in conjunction with each of these plans. More information on the plans and how to comment can be found below.



The Long-Term Renewable Resources Procurement Plan (or Long-Term Plan) is developed and published every two years and details the goals and strategies for the IPA's renewable energy programs and procurements. *Written comments for the draft 2024 Long-Term Plan are due on Friday, September 29.* The IPA will also hold a virtual public hearing for the draft 2024 Long-Term Plan on Friday, September 15. For more information on how to participate in the virtual hearing, and how to submit written comments, see the draft 2024 Long-Term Plan's Cover Letter and Hearing Notice.

The **Annual Electricity Procurement Plan** is developed and published every year and provides a roadmap for the IPA's approach to meeting the electricity supply needs of residential and small commercial customers taking fixed price service from Illinois electric utilities. *Written comments for the draft 2024 Annual Electricity Procurement Plan are due on Thursday, September 14.* The IPA will also hold a virtual public hearing for the draft 2024 Electricity Procurement Plan on Friday, September 8. Section 1-56(b)(3) of the IPA Act allows for up to 5% of Illinois Solar for All (ILSFA) program funding to support community-based organizations and agencies engaging in grassroots education. Grassroots education campaigns ensure that income-eligible households and communities across the state understand the basics of solar energy and receive benefits and eligibility information for participation in the ILSFA program. ILSFA grassroots educators can be community-based non-profits serving cities, towns, and rural communities anywhere in Illinois. ILSFA grassroots organizations have strong local ties and a history of running successful public education campaigns.

To maximize community participation, ILSFA Grassroots Educators create educational resources (like the testimonial highlighted here) to make sure ILSFA program opportunities and benefits reach both rural and urban communities across the state.
